Sugġett: Elezzjoni Kunsill Lokali Belt Valletta 2024

Illum, 05/03/2024, fl-16:00, ġew imsejja l-membri tal-kumitat; il-Viċi Kap — (Is-Sur C. Camilleri), it-Tezoreriera (Is-Sinjura G. Camilleri) u l-kandidati rispettivi tal-Grupp: Is-Sur B. McBee (Kandidat Primarju, Fundatur) u s-Sur P. Borg (Kandidat Sekondarju).

Hekk kif qegħdin fiz-zmien biex il-Moviment Soċjali jaqdi dmiru lejn il-lokalità u r-residenti permezz tal-Elezzjoni tal-Kunsill fejn il-Moviment jiehu xejra ta' partit. Iktar minn hekk, is-Sur McBee vera dedikazzjoni b'bidma infinita lejn il-komunità, mingħajr affiljazzjoni ma' ebda (1) kummerċ, (2) partit jew (3) entità oħra li tista' tkun ta' kunflitt personali jew professjonali waqt il-qadi ta' dmirijetu.

Kopja ta' din l-ittra u d-deċiżjoni uffiċjali se tintbagħat lill-Kummissjoni Elettorali, u huwa deciz b'mod unanimu li tixxandar pubblikament f'isem it-trasparenza li dejjem kienet l-obbligu tagħna bhala moviment/grupp u issa taħt l-operat u funzjoni temporanja ta' 'partit' newtrali u indipendenti għal-lokalità tal-Belt Valletta u tar-residenti Beltin.

Subject: Valletta Local Council Election 2024

Today, 05/03/2024, at 16:00, the members of the committee were called; the Deputy Head — (Mr. C. Camilleri), the Treasurer (Mrs. G. Camilleri) and the respective candidates of the Group: Mr. B. McBee (Primary Candidate, Founder) and Mr. P. Borg (Secondary Candidate).

Just as we are in time for the Social Movement to fulfill its duty towards the locality and its residents through the Council Election, it is now time for our Social Movement to take form of a party. It was unanimously decided, among all the members, that we should work and use our limited financial resources whilst under the hood of non-profit/no-donations/no-sponsor ships on only one candidate.

The selected candidate is Mr.B. McBee. The decision was made on the basis that Mr McBee lives within the locality — and it has always been our principle to find members who are actual residents within the community — while although the other members derive from the Valletta background, unfortunately they no longer live in the City. Furthermore, Mr. McBee has demonstrated an unending dedication to community, with no affiliation with any (1) trade, (2) party or (3) other entity that may be of personal or professional conflict during the performance of his duties.

A copy of this letter and the official decision will be sent to the Electoral Commission, and it is unanimously decided to broadcast publicly in the name of transparency which has always been our obligation as a movement/group and now under the - operation and temporary function of a neutral and independent 'party' for the Valletta area and the Valletta residents.
